Sir/ Madam,

I am directed to inform that Compliance verification assessment of the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Dr. NTR University of Health Sciences, Vijayawada in respect of students being trained at Chalmeda Anand Rao Institute of Medical Sciences, Karimnagar was carried out by the Council Assessors on (17th September, 2014). The compliance verification assessment report (17th September, 2014) alongwith the previous assessment report (28th & 29th May, 2013) was considered by the Executive Committee at its meeting held on 13.1.2015. The following recommendations of the Executive Committee approved by the General Body of the Council at its meeting held on 26th & 27th March, 2015 :-

In case false/wrong declaration of fabricated documents have been used for procuring the approval of Continuation of recognition by the Council and the said misconduct is brought to notice or comes to the knowledge of MCI at any stage, your institution is liable not to be considered for approval of continuation of recognition with the annual intake capacity of 150 students and this approval is also liable to be revoked. Besides, MCI is entitled to take all such measures against you and your college/institution as permissible under the law.
